Training contract

This **Training Contract** (hereinafter referred to as the "Contract") states the terms and conditions that govern the contractual agreement between Lauren Paterson of Wolf Pack Dog Training & Animal Care, having its principal place of business at 1115 Gresham Rd Cadiz KY 42211 USA (hereinafter referred to as the "Trainer"), and _____ (hereinafter referred to as the "Client") who agrees to be bound by this Contract.

WHEREAS, the Trainer holds significant expertise in Dog Training and offers training services in multiple dog competing venues for which the Client would like to engage the Trainer according to the terms and conditions herein.

TRAINING

Your dog's training will be conducted by myself and potentially a number of other carefully selected trainers/handlers that might be needed for protection training, handling in trials or conformation shows. Training sessions by me will be comprised of Basic Obedience and Off Leash Obedience including but not limited to the following subjects:

PUBLICITY AND MARKETING

PAYMENT

A **non-refundable reservation deposit** of $\frac{1}{4}$ (a quarter) of **Total Service Value** is due to reserve a space for the dog scheduled for the extended stay, *previous* to dog's arranged arrival. That amount will be applied towards the 1st half of the full amount due. The **total** cost to be paid to the Trainer by the Client for the services hereunder shall be \$_____.00.

\$_____.00 shall be paid at the implementation of this Agreement and \$_____.00 shall be paid at the midpoint of the scheduled extended stay. Any and all additional funds agreed upon are to be paid in full before the dog is relinquished back to the client. Client is responsible for any and all shipping fees.

CANCELLING TRAINING RESERVATION

The Client acknowledges and agrees that a change in the schedule may present a significant burden for the Trainer and thus the Client shall forfeit the **non-refundable reservation deposit** amount of \$_____.00 previously paid to the Trainer. A portion of the **non-refundable reservation deposit** may be returned at the discretion of the Trainer IF a cancelation notice is sent 30 days prior to shipping/ reserved date.

NO MODIFICATION UNLESS IN WRITING

No modification of this Contract shall be valid unless agreed upon by both Parties. Any amendment made will be done in writing, documented and signed by both Parties.

APPLICABLE LAW

This Contract and the interpretation of its terms shall be governed by and construed in accordance with the laws of the State of Kentucky and subject to the exclusive jurisdiction of the federal and state courts located in Western Kentucky.
